General Information

Entry Forms

The Mercer County Tournament Boy's Lacrosse Entry forms are due on Tuesday, April 19, no later than 10:00 am. All forms must be faxed or emailed to the John Miranda, Tournament Director at 609-806-4291. Email address is john_miranda@monet.prs.k12.nj.us.

All forms should include:

- Roster form (use same format as enclosed sample)
- Entry form – completed and signed
- Officials Information Sheet

Entry Dates

- All games played through Monday, April 18, 2011 will count towards the seeding selection.
- All forms are to be faxed to the Tournament Director, John Miranda on Tuesday, April 19, no later than 10:00 am.
- Teams will be seeded on Tuesday, April 19th. All completed MCT Brackets will be sent to all schools via fax or email by 2:00 pm April 19th.

Seeding Criteria

- Seeding will be done according to the State Lax Power Rating for all teams including all games played through Monday, April 18th, 2011.

The dates for the **2011 MCT Boys Lacrosse** are as follows:

Play-In Round – to be completed by Saturday, April 23rd, 2011

Preliminary Round – To be completed by Saturday, April 30,

Quarter Round - Saturday, May 7th

Semi-Final Round - Monday, May 16th, (Princeton High School/Robbinsville High School/Time to be determined)

Championship – Wednesday, May 18th, (Robbinsville High School/Time to be determined)

All games up until the semi-finals and championship will be played at the higher seeded team. One consolation round will be played at the higher seed. Semi-final and Championship games will be played on May 16th and May 18th unless there is a conflict with the prep playoffs. Dates of semi-final and championship games will then be played based on agreement between both athletic directors and tournament director. **JV games can be played following MCT games, pending prior agreement between both athletic directors.**

Officials

Officials will be assigned by the CVC./MCTA Boys Lacrosse Assignor. The HOME team will be responsible for paying both officials. **Exception:** Schools will split paying for officials of semi-final games. Championship Game will be paid by the Mercer County Tournament Association.

Transportation

Schools will be responsible for their own transportation.

Balls

Balls will be provided by the higher seed school for all rounds up until the championship round. The tournament director will provide balls for the Championship Game.

Games

Game will consist of four periods of 12 minutes. In the event of a tie at the end of the regulation game, play shall be continued, after a two-minute intermission, with sudden-victory overtime.

In sudden victory overtime, the teams shall play periods of four minutes each until a goal is scored. The game ends upon the scoring of the first goal. There will be a 2-minute intermission between sudden-victory periods.

Results

It is the responsibility of the Head Coach of the winning team to call newspapers with results.
